## January 18, 2021 Unofficial Minutes Russell County Commission Meeting

At 9:00 am Steve Reinhardt made the motion to open the meeting Daron Woelk seconded and Duke Strobel approved. Others present for the meeting were: Clerk Mary Nuss, Administrator John Fletcher, County Attorney Dan Krug and Treasurer Trish Strobel. Others attending portions of the meeting were: Chris Brown, GIS Director, Sheriff Fred Whitman and Appraiser Kenton Lyon.

Steve Reinhardt made the motion to approve the minutes of the January 4, 2021 meeting. Duke Strobel seconded and Daron Woelk approved.

Kenton Lyon, Appraiser, explained to the Commission the process of the Tax Corrections that they sign. Tax corrections 2020-45, 48-50 were signed with a tax decrease of \$6,147.84.

Alan Kuntzsch, Public Works Director, updated the Commission on road projects in the County.

Discussion was held regarding the Landfill and how the hours and pay works regarding closing on windy days. Alan will bring in to the next meeting their wind policy. Alan Kuntzsch brought in the first 3 quarters of 2020 minimum cost per load at the Landfill.

The road crew is working on the Paradise Blacktop, south of Paradise City, to try to repair it.

OS64 structure at 20086 4-Corners Rd, is complete and the crew will start replacing the fence.

Road and Bridge has 2 graders that could possibly be up for a buyback program. The machine at Lucas has 6,248 hours and the one at Dorrance is 5,595. Steve asked if they could rotate the machines and put the machines at the shop, that may not have a lot of hours, out on the Lucas and Dorrance routes and bring those in to the shop. It was also asked if they could buy extended warranties on these machines. Discussion was held regarding replacing with new or doing a buyback program. No decisions were made today.

Daron Woelk made the motion to appoint Steve Reinhardt as Chairman. Duke Strobel seconded and Steve Reinhardt approved.

Steve Reinhardt appointed Daron Woelk as Vice Chairman. Duke Strobel seconded and Daron Woelk approved.

Duke Strobel seconded and Daron Woelk approved.

Duke Strobel made the motion to declare Friday, December 24, 2021 as a holiday and Friday, December 31, 2021 as holiday. Thursday, December 30, 2021 County offices will be closed to the public to complete year end business and no County employee will be allowed to leave prior to 2:00 pm. Daron Woelk seconded and Steve Reinhardt approved.

At 10:58 am Steve Reinhardt made the motion to enter into a 15-minute executive session for Attorney-Client Privilege with Trish Strobel, Dan Krug and John Fletcher in attendance. Duke Strobel seconded and Daron Woelk approved. At 11:13 am the meeting resumed with no action taken.

Paula Bitter, County Health Nurse, brought in her Letter of Understandings for WIC and Dietary Services for 2021. Steve Reinhardt made the motion to approve the Letter of Understanding with Belinda Kasper for the WIC and Dietary Services. Daron Woelk seconded and Duke Strobel approved.

Paula stated that our positivity rate for COVID has slowed since the implementation of the Mask Mandate on November 20, 2020. November positivity rate was 27.5%, December was 17.1% and 5.9% up to January 18, 2021. Since COVID started 38% of the County residents have been tested. Paula Bitter would like to set up a vaccination clinic at the 4-H Building when more vaccines are available. She is thinking the middle to later part of February for this Clinic. Vaccines could be will be good from 6 months to 2 years, but they don't know.

It was the consensus of the Commission to keep the mask mandate in place until February 16, 2021 where it will be reviewed again at 11:30 am.

Discussion was held with Sheriff Fred Whitman regarding a complaint that cattle is being injured and they are investigating what may be happening to them. The Sheriff's office is patrolling the area more frequently to help discover what is going on.

Steve Reinhardt made the motion to approve and sign the updated Procurement Policy for the County. Daron Woelk seconded and Duke Strobel approved.

Steve Reinhardt made the motion to extend the COVID -19 eighty-hour sick leave until March 31, 2021. This is only for employees that HAVE NOT USED any of this COVID time. Duke Strobel seconded, and Daron Woelk approved.

Daron Woelk made the motion approve Resolution 2021-1 requesting a waiver of the requirement of KSA 75-1120a from the Division of Accounts and Reports to extend through December 31, 2021. Duke Strobel seconded, and Steve Reinhardt approved.

Chairman Steve Reinhardt signed the CMB license for Iron Bird, LLC DBA LaSada Lodge.
