- \* I understand that if I do not cancel by May 20<sup>th</sup>, my information will be included in the Garage Sale Guide. I understand that the registration payment is non-refundable.
- \* I understand that the Sponsors will promote the Garage Sale and that I am responsible for any additional advertising specific to my sale.
- \* I understand the City of Russell Zoning Regulations, which state in part:
  - \* It shall be unlawful to attach in any way any sign, poster or notice of any kind in or upon lamp posts, trees or utility poles whether on public or private property.
  - \* No sign shall be attached to any building or property of the City.
  - \* No sign shall be placed at any location where it may obstruct the view of (or be confused with) any traffic-control sign.
  - \* No sign shall be located in any vision triangle formed by the curb lines at intersections.
  - \* All sale items shall be removed from exterior premises within (1) day following the conclusion of the sale.
- \* I understand that the Sponsors do not warrant, endorse or guarantee any transactions conducted between participants.
- \* I agree that the Sponsors will not be held responsible for any actions or incidents occurring on my personal property or in public areas.
